## **Policy Statement**

Malignant fungating wounds (MFW) are defined as an infiltration of tumour or the metastasis into the skin and can involve the afferent blood and lymph vessels and can develop anywhere on the body. Unless malignant cell growth is under control, either through medical treatment such as chemotherapy, radiotherapy, hormone-therapy, electro-chemotherapy or surgery, the fungation continues growing and as a consequence, it evokes damage to the surrounding tissue through a combination of the loss of vascularity, proliferative growth and ulceration.

The aim of the Recommendations for the Care of Patients with Malignant Fungating Wounds document is to support best practice among nurses who manage such wounds, based on current literature and experiences. The objective is to optimise the management of MFWs based on HTA (the Health Technology Assessment) elements: Method, Medical Treatment, Patients, Organisation, and Economics which should provide a structured approach towards all aspects of clinical and organisational factors, patient care, and health economics.

These guidelines have been developed by the European Oncology Nursing Society and have been endorsed by the Gippsland Region Palliative Care Consortium Clinical Practice Group. Consultation with local wound and palliative care consultants in Gippsland, including the GRPCC Expert Advisory Group, have been undertaken as a part of this process.
